

PRIVACY POLICY

CoreLink Surgical (“CoreLink” or “the Company”) is dedicated to protecting the privacy of your personal information. This Privacy Policy describes how CoreLink treats personal information collected and received from you through the CoreLink Website (the “Website”), which is owned and operated by CoreLink. Personal information includes information about you, such as your name, address, email address, and telephone number. This Privacy Policy applies only to information collected on the Website and does not govern the privacy of any information gathered off-line.

1. Information Collection

CoreLink’s Website does not currently collect email addresses from users, and instead, directs users to email CoreLink for information on products or on being a distributor. However, CoreLink automatically receives and records information on our server logs from your browser, including your Internet Protocol (“IP”) address, browser type, referring page, time of visit, and cookie information.

2. Information Use

CoreLink may perform statistical analysis of Website user behavior in order to measure interest in the various areas of our Website, including for Website development purposes.

3. Information Sharing and Disclosure

CoreLink may provide information gathered from you in the server log to affiliated companies or other trusted businesses or persons who work on behalf of or with CoreLink. These companies or individuals may use your information for product development and marketing purposes and to improve the features and functions of this Website. These affiliated companies or individuals will not use your personal information for business or offers that are unrelated to CoreLink.

CoreLink also may provide personal information about you when required to do so by law or in the good-faith belief that such action is necessary to: (1) comply with the law or comply with a legal process served on CoreLink; (2) protect and defend the legitimate business interests, rights or property of CoreLink, its users, customers, sponsors or affiliates; or (3) act in an emergency to protect the personal safety of our Website visitors, customers, or the public.

CoreLink will not use or share your personal information in ways unrelated to those described above without providing you an opportunity to opt-out or otherwise prohibit such unrelated uses.

4. Security

CoreLink considers security of the functions and content on the Website to be of the utmost importance. To prevent unauthorized access, maintain data accuracy, and ensure the appropriate use of information, we have put in place physical, electronic, and managerial procedures that we believe are appropriate to protect the information we collect online.
